The Monongalia County Commission met in regular session on the 23rd day of April 2025 beginning at 10:02 A.M. in the Monongalia County Commission Meeting Room, at the Monongalia County Courthouse. Agenda attached. No work session was held on this day.

- b) A motion was made by Commissioner Sikora, seconded by Commissioner Bloom and unanimously carried to approve funding up to \$30,000.00 for support of the NCAA Regional Baseball Tournament at the Monongalia County Ballpark Complex.

- c) A motion was made by Commissioner Sikora, seconded by Commissioner Bloom and unanimously carried to approve a Resolution and Order of the County Commission to authorize the issuance of the Amended and Restated Tax Increment Revenue Bonds, Series 2021 B (Harmony Grove Phase I Infrastructure Project), in the principal amount of \$21,500,000 (the "Amended and Restated Bonds") in exchange for the County Commission's currently outstanding \$21,500,000 Tax Increment Revenue Bonds, Series 2021 B (Harmony Grove Phase I infrastructure Project) ("Original Bonds") in order to modify certain terms of such Original Bonds; authorizing the execution and delivery of the Amended and Restated Bonds, a First Supplemental Indenture of Trust, a First Amendment to Development Agreement and other documents relating to the issuance of the Amended and Restated Bonds and matters relating thereto. Tom Aman, Bond Counsel for the Monongalia County Commission, provided additional details on the scope of the project. Glenn Adrian, Enrout Properties, provided details on the Harmony Grove TIF (Tax Increment Financing) District.
- d) A motion was made by Commissioner Sikora, seconded by Commissioner Bloom and unanimously carried to approve a Resolution and Order of the County Commission to amend the boundaries of The County Commission of Monongalia County Development District No. 5 Harmony Grove pursuant to Amended Project Plan No. 1 for such District as authorized by the West Virginia Division of Economic Development.
- e) A motion was made by Commissioner Sikora, seconded by Commissioner Bloom and carried (with Commissioner Arnett abstaining) to approve the appointment of Commissioner Arnett to the MECCA Policy Board and the Monongalia County Community Corrections Board.
- f) A motion was made by Commissioner Sikora, seconded by Commissioner Bloom and unanimously carried to approve a three-party agreement between the Monongalia County Development Authority, the City of Morgantown, and the Monongalia County Commission that sets forth the understanding, acceptance, and agreement regarding the establishment and funding of an Interest Reserve Account approved by resolution of the Commission on August 21, 2024. Russ Rogerson, President of the Morgantown Area Partnership, presented comments on the East End Addition project.

10. Reports from Elected Officials and Department Supervisors -

Alex Hall, Litter Control Officer – New recycling bins at the Monongalia County Recycling Center (preventing unwanted items, decreasing staff time to remove full bins), highlights of his time at the job (integrating with MECCA 9-1-1, coordinating with Prosecuting Attorney's office), thanked the staff in his department, interim staff will be covering his duties, thanked the Commission for the experience working for the county.

11. Reports from County Commissioners

Commissioner Bloom – Commented on the recent storm (damage in the community, thanked first responders and members of the public who provided assistance).

Commissioner Sikora – Call regarding Chaplin Hill project, broadband project tag-up, Governor declared half-day holiday for Good Friday, commented on the recent storm (multiple power lines down, members of the public provided assistance, lengthy power outages, thanked staff at Mon Power for their work during the outages), call with legal counsel about Development Authority agreement, participated in Annual Earth Day assembly at Eastwood Elementary School, responded to MaryAnn Folz's public comments and directed her to the Commission's website for information about Tax Increment Financing Districts.

Commissioner Arnett – Commented on the recent storm (grateful there were no injuries, thanked First Energy/Mon Power for their response to the power outages, thanked county maintenance staff for responding to damage at Chestnut Ridge Park).
